4.1 The Committee discussed the summary paper outlining the history of its annual reports and giving a proposal for its 2020-21 report and agreed to proceed with it, and all future reports, in a digital format only. It noted that the 2020-21 report would be laid in Parliament with the Secretary of State's report on the Operation of the Control which would henceforth be separate from the Committee's report as it had been before the two were combined from 2004/05.

The importance of disseminating the Committee's work via digital channels and of updating the website was noted and the Committee asked to be consulted on any proposed communication plan to mark the 70th anniversary of the publication of the Waverley Report.
